Why is this course needed?

To become and remain Authorised to work on the Essential Energy network, accredited service providers (ASPs) must be re-assessed annually. This training allows you to provide that evidence.

This training supports the need for national mobility of the ESI workforce and provides a standardised approach for workers to gain and maintain approval to work on or near electrical supply industry networks.

Unique Student Identifier

Participants undertaking this course must have a Unique Student Identifier (USI) number. The USI is a reference number allowing students to access all their training results from all Vocational Education Training (VET) providers. The USI is available online and at no cost to the student and stays with that student for life. If you have not yet obtained a USI you can apply for it directly at <u>http://www.usi.gov.au/create-your-USI/</u>.

Eligibility to attend this course

Participants undertaking this course must be able to demonstrate previous assessment within three years of proposed assessment date with either:

- Essential Energy
- An Essential Energy approved Registered Training Organisation (RTO) <u>or</u>
- Been previously issued National Refresher Units by another RTO

If participants have attended this course with another RTO, transcripts must be supplied along with the completed RTO enrolment form.

What will the course do for you or your employees?

Following successful completion of the annual refresher training and assessment, participants will be issued a Nationally Recognised Statement of Attainment (SoA). This will be issued via post.
