To be an Access Permit Recipient a person must have successfully completed this course and demonstrated a understanding of where work is allowed to be undertaken, what information is needed on the form and what each individuals responsibilities are.

## Eligibility to attend this course

People undertaking this course must:

- Hold a current ASP authorization with Essential Energy and who are current in their regulatory training, and
- Be electrically qualified people who are required to act as an access permit recipient when working on or near Essential Energy's network.

Following successful completion of this course the participant will be authorised to receive an access permit for work on or near Essential Energy's network.

# Requirements to remain authorised after initial training

To remain authorised as an Access Permit Recipient, refresher training is required every 2 years.

Refresher training needs to be conducted before the expiry date of an individual's authorisation.
