# **Essential Energy Work Near Overhead Powerlines (WNP) Course**



Essential Energy training team is pleased to offer the Work Near Overhead Powerlines (WNP) course. Aligned to the SafeWork NSW Code of Practice 2006 - Work Near Overhead Powerlines, training is offered as either Initial Training for new entrants, or annual Refresher Training to existing workers.

# Why is this course needed?

Contact with overhead powerlines is a serious risk and is one of the largest single causes of fatalities associated with mobile plant and equipment.

The SafeWork NSW Code of Practice aims to protect the health and safety of persons by managing the risks associated with work near overhead powerlines and includes references to the legislative obligations of persons conducting a business or undertaking (PCBU), officers, and workers who are required to work in close proximity to overhead powerlines.

### Eligibility to attend this course

People undertaking this course must:

 Hold a current SafeWork NSW OHS Induction for Construction Work General Authorisation

#### **Refresher Courses**

To remain compliant with the SafeWork NSW Code of Practice, refresher training is required annually. Only students who have completed initial or refresher training within 3 years of course date are eligible to attend a refresher course.

# What will the course do for you or your employees?

Once successfully completed, participants will receive an identification card that is recognized in NSW for a period of 12 months. This will enable workers to be able to work to reduced clearances in accordance with the WNP Code.

#### **Course content**

The course includes:

- Basic electricity
- The power system
- Electric shock effects and prevention
- How to determine voltage levels of electrical apparatus
- Application of safe approach distances
- Rescue and escape in an electrical situation
- Cardio-pulmonary resuscitation
- WorkCover requirements
- Safe working practices.

Competency assessments are completed as part of the course and are based on practical/oral and written assessments.
