SAFETY STAR SUPERHERO COMPETITION

Terms and Conditions:

1. The promoter is Essential Energy ABN 37 428 185 226 of PO Box 5730 NSW 2444. Phone 13 23 91.
 2. Information on how to enter and the prizes form part of these Terms and Conditions.
 3. The competition will be known as the "Safety Star Superhero Competition".
 4. The competition is open to all students from Year 5 to Year 6 across all primary schools in our network areas registered to participate in Electricity Safety Week (ESW) 2023 and who receive a resource kit from Primary Communications.
 5. There is no cap on the number of entries each registered school can submit – it is unlimited - however students must submit an individual entry for their entry to be eligible. Team or class entries will not be eligible.
 6. Entries can be submitted by teachers or school principals on behalf of their class or school, using one of the following methods:
 - Complete the online entry form located at essentialenergy.com.au/superherocomp
 - Email a colour scan or photo of the completed poster template and entry form contained within the ESW 2023 resource pack to: esw@essentialenergy.com.au
 - Mail the completed poster template and entry form contained within the ESW 2023 resource pack to: Essential Energy, "Safety Star Superhero Comp", PO Box 5730, Port Macquarie NSW 2444.
 7. Original comic strips and entry forms received cannot be returned.
 8. Entries open 9am Monday 17 July and close 5pm Friday 27 October 2023.
 9. For the entry to be eligible, it must contain the following:
 - Full name of school and town
 - Year group, teacher name, student name and class name
 - Contact email address and phone number for the school
 - A comic strip design which is an original creation by the student. It must include one or more of the program electricity safety messages, or an electricity safety message of the student's creation.
 10. By entering the competition the entrant/school acknowledges that they give Essential Energy permission to reproduce all or part of the entry in one/all of the following ways – sharing on Essential Energy's social media accounts, on Essential Energy's website, in Essential Energy media releases, in internal publications, for inclusion in future Electricity Safety Week materials or as part of an Essential Energy safety campaign. Entry into this competition does not guarantee reproduction of the entry in the above-mentioned methods.
 11. One major prize winner will be judged from all entries using a merit selection process with the following judging criteria:
 - The comic strip design must incorporate an electricity safety message (which can be one of the program safety messages or a new message of their own creation and design)
 - The comic strip must feature a superhero design as part of the design or message
 - Creativity and originality of electricity safety tip, superhero and comic design.
 12. The winning design must be supplied to Essential Energy in hard copy and/or also emailed as a high res PDF.
 13. The winner will be selected by a judging panel comprised of three Essential Energy representatives. Judging will take place between Monday, 13 November and Friday, 17 November 2023. The judge's decision is final.
 14. The winners will be notified w/c Monday, 20 November 2023 by email or telephone where applicable.
 15. The names of the winning schools/classes and entries will be published on the Essential Energy website at essentialenergy.com.au/superherocomp and Facebook page w/c Monday, 27 November 2023.
 16. There will be one major prize winner and the prize includes:
 - A donation of \$1,000 to the winning school's P&C Association, to be put towards a safety related improvement for the school
 - Silverlit Ycoo Neo Remote Control Robo Up valued at \$99.99 RRP.
- There will be two runner up entries selected and the prizes include:
